As a member of the California Workforce Connection, CWC you are entitled to obtain access to the Members Only section of our website. The procedure is simple and quick. All you need to do is contact BJ Sims at: bitsims@ gmail.com and ask her for access. You will need to

send her your personal email address NOT your EDD email address.

BJ usually answers your request within hours if your request is sent to her Monday through Friday. Any requests received during the weekend might take a little longer. As part of the process you will have to access the **Members Only** section with the password, she will send to you. You need to reply to her that access to Members Only was successful.

This will allow you to have access to all the same information all your CWC Officers and fellow members have. Transparency is a good thing!

Is Big Tech Watching You?

Yes, every time you browse the Internet snippets of your information are saved by the browser. Those snippets are cookies which are small packets of data saved as text files on the web browser of your computer or other devices. The website you are visiting creates these cookies - small bits of code, to collect data from your browsing history.

Cookies can be useful as they keep track of items in your shopping carts and save your information – including login credentials – so sites can remember you and your preferences. However, cookies also may undermine your privacy and security.

Deciding whether to accept or clear these cookies may depend on the kinds of cookies in question. There are three types of computer cookies.

Session cookies – text files that are stored in a temporary folder. Session cookies do not collect your data and are deleted when your browsing session ends.

Stored cookies – cookies that do track your online preferences, like login credentials, to improve your website experience. Stored

cookies will expire after some time has passed.

Third-party cookies – the cookies that track you. Thirdparty cookies collect your data when you visit a website and may be shared with or sold to third-party advertisers.

Norton states that "depending on which cookies you're dealing with, they can pose a privacy risk due to the type of personal information they're collecting - and what they're doing with that data." Is having cookies a bad thing and should you clear them?

"The answer depends on the website you're visiting in terms of who will gain access to your data and what they will do with it, along with whether clearing cookies will affect your ability to use that site. Since all cookies are not the same, there are several reasons why you may or may not want to delete cookies."

Three reasons you may not want to delete cookies from your browser.

Website access. One problem with refusing to accept cookies is that if you do not accept cookies, some website owners may not allow you to use their websites.

A better user experience. You may not receive the full user experience on

certain websites if you decline computer cookies. For example, cookies can remember and save helpful data about you, like your interests or leftover shopping cart items.

Easier, quicker log-ins.

Computer cookies saved on your web browser can help you use your favorite websites more efficiently. They can make online transactions extremely convenient, as you do not have to enter your information every time you visit a site. Instead, logging into your favorite websites is quick and easy.

To be on the safe side, you may want to do a periodical clean-up on your PC to get rid of old unused or risky cookies that have been collected to limit the information being shared or sold to third-party advertisers.

- Most popular browsers provide step-by-step instructions on how to clear cookies from the latest versions of Google Chrome, Firefox, Safari, and other popular web browsers. You can Google how to delete cache and cookies for the browser you use for detailed instruction.

respective 'Settings and Privacy' tabs, and then clear the cookies in your website browsing data and history. In addition to clearing your cache, you can customize which cookies will be deleted based on a specific time range and other options.

• Taking into consideration what

types of cookies are involved can help you decide if clearing these files are necessary to keep your information private and safe. Otherwise, if your sensitive data falls into the wrong hands, you may be leaving yourself vulnerable to online frauds like identity theft.



Nominees should have demonstrated exceptional accomplishments in advancing CA Chapter objectives, e.g. leadership on a board, committee or initiative group (not restricted to CA Chapter); participation in educational, membership, communication, fund-raising or legislative activities; mentoring chapter leaders and/ or participation that advances the member's local community.

Employee Performance Award (EDD & Partner)

- Eligibility: Member - individual and group -Recognizes an individual or group who has gone above and beyond their assigned duties to provide outstanding service to the public through excellent performance. The Nominee must have demonstrated exceptional achievements that contributed to the smooth performance of operations through positive attitude, accuracy, representing the agency with the public, handling workload under unusual conditions, adaptability, initiative and dependability.

Customer Service -Eligibility: Member or Non-Member - individual and group- Recognizes exceptional

service to customers served throughout the workforce system including, but not limited to work with job seekers, UI claimants, businesses, schools, and vocational rehabilitation, people with disabilities, former felons, youths, welfare recipients and job training participants.

Fostering Partnership **Award** – Eligibility: Member or Non-Member – individual and group - Recognizes an individual or group who has demonstrated diligent efforts to partner with the EDD and/ or CA Chapter while collaboratively delivering valuable and innovative services to meet the evolving needs of members, employers, workers, and job seekers. Partner organizations such as the Department of Rehabilitation, Workforce Investment Act Partners, the Small Business Administration, Employment Advisory Councils, Chambers of Commerce, governmental agencies, etc. all play an important role in the workforce system and employment security, so the CA Chapter would like to acknowledge them accordingly.

HOW TO SUBMIT YOUR NOMINATION:

The nomination must be typed, double-spaced, 11 or 12 size fonts, on 8½ x 11-inch paper.

- > Standard Nomination Form. This form must be the first page of every written nomination.
- > Narrative. This concise, precise and descriptive narrative must focus on the details/ examples of the actual accomplishment and include any necessary background information that explains why the accomplishment was exceptional to the association or agency. Give information based on the criteria listed on the judging heet (found on the website in the Local Chapter
 - Handbook), as this will assist the judges in properly and efficiently scoring the nominations.
- > **Documentation.** The narrative must be supported only by documentation that relates directly to the accomplishment activities on which the nomination is based. The documentation may be articles, endorsements, recommendations, testimonials, or original and/ or digital photographs with a brief description of what each photograph is intended to show.

If you need help writing an award nomination, look at awards on the CWC website. For those award categories where a non-member could win, the nomination must be written by a member. For those awards that are only given to CA Chapter Members, CA Chapter membership is required in both the year during which the activity occurred (2021) and the year in which the nomination was submitted (2022).

On October 16, 2021, District III sponsored a Work-Life Balance Zoom Presentation hosted by the LA Chapter. The presentation was facilitated by Alma Diaz, LA/Coastal Program Coordinator and Treasurer for the LA Chapter. She emphasized that the work-life balance is an important aspect of a healthy work environment to the ten attendees. Maintaining a work-life balance helps reduce stress and helps prevent burnout in the workplace.

Chronic stress is one of the most common health issues in the workplace. It can lead to physical consequences such as hypertension, digestive troubles, chronic aches, pains, and heart problems. Chronic stress can also negatively impact mental health because it is linked to a higher risk of depression, anxiety, and insomnia. Too much stress over an extended period leads to workplace burnout. Employees who work tons of overtime hours are at a high risk of burnout. Burnout can cause fatigue, mood swings, irritability, and a decrease in work performance.

The training was at the request of members from the Inglewood Unemployment Insurance office. The workshop shared the importance of evaluating your life and finding what needs to balance. What brings joy and what creates stress and making a conscious decision to create a balanced life. Once you take the time to focus on yourself and your health, then you can move forward and find a Work-Life Balance that works for you. Understand that there is no "Perfect" work-life balance, one-size-fits-all balance, you should be striving for.
