## STEP UP AND LEAD

#### Bybee Grant Application: Essential Tips for Success

#### Tip #1

Do your research before starting a training program, make sure the training provider is an accredited organization.



You must have been a member in good standing for one year at the time you submit your application.

#### Tip # 3

You must have completed the training prior to applying for the Bybee Grant.

#### Tip # 4

You must have attended a single course,program, or related activity which clearly relates to your professional advancement in the field of workforce development.

#### Tip # 5

The course cannot be a required course for a degree or the purpose of matriculation.

#### Tip # 6

The course is related to career advancement or enhancement of skills in workforce development fields.

#### Tip # 7

Make sure all fields in the application are complete and the form is signed.

#### **Tip # 8**

Attach all required documentation such as: Training provider's description of the course, class, certification exam, or training.

#### Tip # 9

Respond to any follow-up inquiries from the Board promptly.

#### Tip # 10

The Bybee trustees can approve grant requests up to \$750 or two grants per member, per fiscal year, whichever is less.
