ARTIFICIAL INTELLIGENCE AND A BRAVE NEW WORLD

As a teenager, I would sit and watch in awe of the sci-fi TV drama Star Trek to hear the open monologue by Captain Kurt in a low, monotone voice, "Space the final frontier, these are the voyages of the spaceship enterprise, its fiveyear mission to explore strange new worlds to seek out new life, new civilizations to boldly go where no man has before."

Star Trek presented a futuristic picture of an advanced society where robotic androids acting with mannerisms akin to humans will exist in unison with humans. Our daily life would undergo significant transformation due to the integration of these profound technological advances. A robotic android will respond to verbal commands, like when Captain Picard requests information from the android data. Furthermore, in Star Trek, we enthusiastically saw the technology of the future instantly when Lieutenant Uhura would be writing on a table, which is today the iPad, or when Captain Kurts would be speaking to Scotty on a

gadget that's now the cellular phone.

Moreover, movies like iRobot. where robotic androids display very human-like characteristics, and probably the most famous and iconic robotic android is the Terminator, who infamously said, "I'll be back." This Al robotic android made the evolution in Al robotic technology natural.

The 21st century, like the preceding century, opens with contradictions and great possibilities in human development, ranging from new forms of social and organizational structures. which inevitably recast social relationships profoundly, meaning, of course, ethics, values, and the reproduction of human existence. The driver behind this new incoming reality and what is being called the Fourth Industrial Revolution 4.0 is Artificial Intelligence (AI).

Al is the supposition and evolution of computer systems that can perform duties that generally require human intelligence, such as visual perception, speech recognition, decision-making, and language translation. Al will take over monotonous, repetitive tasks, improve communication, increase collaboration, and expand disciplines. This technology will and is becoming increasingly involved in day-to-day business operations. Autonomous robots, through predictive analytics, will enable business enterprises to streamline the production process, increase productivity, and reduce environmental damage. More importantly, (AI) at this stage of development will not replace humans in the production process per se but will augment human abilities and enable us to work more safely and efficiently.

Cobots are the new iteration in (AI) robotics. They are inexpensive to operate, don't require a space to operate from, and safely work without requiring protective cages or segregation from workers.

Award Categories

Award of Distinction

Eligibility: Member or Non-member – individual and group Recognizes outstanding contributions to the CA Chapter or to workforce development programs. The recipient(s) must be from the private sector or a non-governmental, nonprofit organization and not employed by a workforce development entity.

Award

Meritorious Eligibility: Member or Non-member - individual and group Recognizes outstanding contributions to the CA Chapter or to workforce development programs. The recipient(s) must be from the private sector or a non-governmental, nonprofit organization and not employed by a workforce development entity.

Veterans Award

Nominees should have demonstrated exceptional accomplishments in advancing CA Chapter objectives, e.g. leadership on a board, committee or initiative group (not restricted to CA Chapter); participation in educational, membership, communication, fund-raising or legislative activities; mentoring chapter leaders and/or participation that advances the member's local community

Emplouee Performa nce Award (EDD & Partner)

Eligibility: Member - individual and group Recognizes an individual or group who has gone above and beyond their assigned duties to provide outstanding service to the public through excellent performance. The Nominee must have demonstrated exceptional achievements that contributed to the smooth performance of operations through positive attitude, accuracy, representing the agency with the public, handling workload under unusual conditions, adaptability, initiative and dependability.

Customer Service

Eligibility: Member or Non-member - individual and group Member or Non-Member - individual and group -Recognizes exceptional service to customers served throughout the workforce system including, but not limited to work with job seekers, UI claimants, businesses, schools, and vocational rehabilitation, people with disabilities, former felons, youths, welfare recipients and job training participants. **CONTINUED ON PAGE 12**

Award Categories

Fostering Partnership Award Member or Non-Member – individual and group

Recognizes an individual or group who has demonstrated diligent efforts to partner with the EDD and/ or CA Chapter while collaboratively delivering valuable and innovative services to meet the evolving needs of members, employers, workers, and job seekers. Partner organizations such as the Department of Rehabilitation, Workforce Investment Act Partners, the Small Business Administration, Employment Advisory Councils, Chambers of Commerce, governmental agencies, etc. all play an important role in the workforce system and employment security, so the CA Chapter would like to acknowledge them accordingly

2023 SUBMISSION COMPONENTS

The nomination must be typed, double-spaced, 11 or 12 size fonts, on $8\frac{1}{2}$ x 11-inch paper.

Standard Nomination Form: This form must be the first page of every written nomination.

Narrative: This concise, precise and descriptive narrative must focus on the details/ examples of the actual accomplishment and include any necessary background information that explains why the accomplishment was exceptional to the association or agency. Give information based on the criteria listed on the judging sheet (found on the website in the Local Chapter Handbook), as this will assist the judges in properly and efficiently scoring the nominations.

Documentation: The narrative must be supported only by documentation that relates directly to the accomplishment activities on which the nomination is based. The documentation may be articles, endorsements, recommendations,

testimonials, or original and/ or digital photographs with a brief description of what each photograph is intended to show. If you need help writing an award nomination, look at awards on the CWC website. For those award categories where a non-member could win, the nomination must be written by a member.

For those awards that are only given to CA Chapter Members, CA Chapter membership is required in both the year during which the activity occurred (2023) and the year in which the nomination was submitted (2024). **Nominations must be submitted by February 14th.**

Cobots can preselect components to carry out tasks like screwing, sanding, and polishing, in addition, to carrying out quality inspection control. While this is fascinating in the evolution of technology, there are several stages of AI.

The first stage is the rules base or knowledge base; this is where AI operates not intuitively but learns on a predefined set of rules. This type of AI can be found in many everyday technologies, such as home security devices, alarm clocks, thermostats, microwaves, and car radios.

Secondly, it is context-based and not only processes immediate inputs but responds to the surrounding environment by using behavior, historical data, and real-time cues to make informed decisions and predict user's needs. Siri, Lexa, and Google Assistant are examples of this form of Al. Its retention system can retrieve information from previous interactions.

Thirdly, Narrow or Domain AI is tailored to master specific tasks and is used in the stock market to track trends, analyze market patterns, and predict stock movement beyond what any trader can do.

Fourthly, Reasoning or chat GPT simulates complex human processes that humans use daily to analyze data and identify anomalies by connecting patterns and drawing logical conclusions. An example is selfautonomous vehicles, or, in other words, driverless cars.

Finally, Artificial General Intelligence is a more advanced form of AI that can perform any software task. Humans can learn a million times faster than the human brain. Moreover, Artificial General Intelligence can, with the use of quantum algorithms, model human consciousness, understand your mood, and when the brain-computer interface reaches an adequate level of maturity, humans can merge with this type of AI and communicate in real-time by employing thoughts.

Furthermore, by the end of the century, AI could be trillions of times more intelligent than humans, thus becoming transcendent. Futurist Ray Kurzweil, an advocate of the transhumanist movement and author of The Transcendent Man, further maintains that AI will become super-intelligence and will exponentially grow in intelligence, eclipsing the combined cognitive ability of

every human that ever existed and tackle problems that were deemed unsolvable. Moreover, the advancement of AI will lead to its ability to become self-aware of being a model human consciousness and possess a full range of emotions and sensitives.

In addition, transcendent Al can formulate new life forms. whether biological or digital. It is postulated that AI will ultimately be able to pierce the dynamics and complexes of the cosmos. While AI technology is heavily employed in the private sector and has shown great success in improving the development of goods and services, the federal, state, and local government sectors also employ this technology. California State government recognizes Al's transformative and salutary effects in enhancing first-class efficiency, accuracy, and competency in adjudicating fairness in service delivery.

For example, Megan Carbonell, Employment Development Administrator for the Inland Empire, in a staff briefing, informed everyone about the new software the Disability Insurance Branch will be launching to enhance the customer relations experience

for a more pleasurable encounter and promote efficiency. Amazon Connect will have an Interactive Voice Response (IVR) component that will employ voice recognition, allowing the user to engage the system as though you are interacting with a person, also, there's a chatbox where the user can type in a question and get an immediate reply, aiding the user in getting information and issues resolve quickly, thus saving time and allowing claim examiners to work on more problematic claims.

Al technology's potential to revolutionize the California workforce is acute. However, there may be unforeseen drawbacks that may have deleterious consequences for its application to ensure Al efficaciousness and safety. State Senator Scott Wiener authored SB294 the Safety in Artificial Intelligence Act, the bill intends to require rigorous testing for AI models and planned safety contingency measures of action for safety breaches. Moreover, the bill will ensure that California remains the powerhouse for AI innovation while steering Al's technological development safety convention and creating the CalCompute cloud base cluster for Al researchers, held by the UC educational system. Applying science and technological innovations

ranging from simple tools such as the hammer to the wheel and horse buggy has enabled humans to navigate and impact their physical environment.

These technological innovations are an outgrowth of science, which serves a social function in the human experience. Through technical innovation, science is a means to satisfy our material needs. In other words, science is to be one of universal beneficence and a continuous progressive improvement in the conditions of life. Science is not an abstract endeavor but concretely grounded in the material reality of the human experience and not set apart from society's influences.

On the contrary, it is shaped and determined by the prevailing social institutions, economic, political, cultural values, and ethos at a historical epoch. In the United States, the primacy of private property is associated with freedom and is considered the highest value. While a private entity does not particularly own science, the technology resulting from its inquiry is private ownership. On this private property, the owner can determine when, where, and how the technology will be implemented and at what cost.

Consequently, a paradox occurs when the private interest of the individual owner interest conflicts with the broader interest of humanity or the utilitarian social function of science. Being that the social benefits of AI are transformative and lifeaffirming, that will profoundly impact every aspect of human life, raises a crucial social question as to whether technology, such as AI, should be collectively owned and used for the benefit of all human society or be privately owned by a few. As AI evolves, it will become more potent due to increased intellectual capacity. It could influence governments beyond the control of human participation by way of mega-corporations.

Star Trek introduces a captivating universe where human life is free from the socio-political conflicts prevalent in the 21st century. Portraying a 22nd-century future, the series envisions abundant material sustenance and creative leisure facilitated by artificial intelligence (AI). However, the advent of AI brings both promise and peril, with the potential for radical changes and the looming specter of a dystopian reality, reminiscent of Terminator, due to its unpredictable implementation and raison d'etre (purpose).
